COMPLETION OF PLACING OF NEW SHARES UNDER GENERAL MANDATE

The Board announces that all conditions of the Placing have been fulfilled and the completion of the Placing took place on 17 June 2013. 9,600,000 Placing Shares have been successfully placed by the Placing Agent to six Placees at the Placing Price of HK\$0.83 per Placing Share pursuant to the terms and conditions of the Placing Agreement.

Reference is made to the announcement of the Company dated 4 June 2013 in respect of the Placing of the new Shares under General Mandate (the "Announcement"). Unless defined otherwise, capitalized terms used herein shall have the same meanings as those defined in the Announcement.

COMPLETION OF THE PLACING

The Board announces that all conditions of the Placing have been fulfilled and the completion of the Placing took place on 17 June 2013. 9,600,000 Placing Shares have been successfully placed by the Placing Agent to six Placees at the Placing Price of HK\$0.83 per Placing Share pursuant to the terms and conditions of the Placing Agreement.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, the Placees are independent third parties. The Placees have not become a substantial Shareholder (as defined under the Listing Rules) immediately after the Placing. The net proceeds from the Placing, after deducting the placing commission of 1.5% on gross proceeds and other expenses in connection with the Placing, is approximately HK\$7.85 million which is intended to be used for general working capital of the Group.

SHAREHOLDING STRUCTURE OF THE COMPANY

9,600,000 Placing Shares represent approximately 4.42% of the issued share capital of the Company immediately after completion of the Placing. The aggregate nominal value of the Placing Shares issued under the Placing is HK\$1.92 million.
